- Late registration --- **\$60.00 -and- contribution of item valued at \$25 for event raffle.**

### General Event Guidelines - Zuni MainStreet Festival

1. All Artists/Vendors must have a current valid Peddler’s Permit for this event. Food vendors must also have a current valid Food Handler’s Permit.
2. **Early registration deadline is 5:00 pm on Friday, April 27, 2018. Late registration deadline is 5:00 pm on Friday, May 4, 2018.**
3. **Event Check-In and Set-up will begin at 9:00 am on Saturday, May 5, 2018.** Please bring your receipt for check-in/verification and to receive your name badge and booth sign.
4. Please display your booth sign so that you can be identified as a MainStreet Festival participant.
5. Artists/Vendors are responsible for bringing their own tables and chairs, canopies and necessary equipment.
6. Conduct yourself professionally at all times. The Zuni MainStreet Festival is a Drug/Alcohol Free event.
7. Parking will be available in designated areas. Please check with Event Coordinators.
8. Setup at alternative locations along MainStreet is welcome and encouraged. However, please inform Event Coordinators ahead of time so that your booth location can be promoted.
9. Paid fees are NON-REFUNDABLE for non-attendance of the event.
